
The Edgar County Community Foundation



AGENCY ACCOUNTS & SCHOLARSHIPS

Contributions can take a multitude of forms, including cash and gifts in kind, such as securities, and real estate. Your donation can be a planned gift from a charitable lead trust, or a bequest to the Foundation made through a will, estate plan or insurance policy. Donors may establish particular funds within the Foundation to accomplish a single purpose.

- Agency Accounts: other foundations
